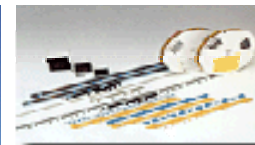
- > **Jodo Inc promotes the environment protection activities in order to realize such environment where people and nature harmonize and sympathize each other.**
